1. Account-level signature rights

Each user may have three different access rights with respect to the Account Holder's accounts: 1. forbidden (no right, he cannot even view the account), 2. query right and/or 3. signature right. An access right can be defined uniformly with respect to all the accounts or individually, separately for each account.

Signature rights are measured by Commerzbank Electra in a scoring system. Each user receives a signature right of a value of maximum 10 points. The sending of a signed package to the Bank requires at least 10 points. The 10 points can be accumulated from the points of a single user or of several users who sign jointly.

On the basis of the above, please choose from the following options:

The User should have a query right for all accounts of the Account Holder. (In this case the user will automatically receive a right with respect to any accounts that are opened in the future!)

Score of the signature right: __ points

The User has a separately defined access right for each account. (In this case a new Annex 2 needs to be completed for the user with respect to any accounts that are opened in the future!)
